Generally

This booklet states the prices in Harstad Havn KF (hereinafter referred to as Harstad Havn). For information about the conditions for the prices and exceptions, see *Terms of Business for Harstad Port*. All prices referred to are excluding VAT.

1 Use of maritime infrastructure

1.1 Fairway fee

The Fairway fee is calculated based on gross tonnage (GT). Exemptions and discounts are described in the business terms for the Port of Harstad.

Vessel type: Combined general cargo/passenger ship in coastal scheduled shipping is billed at 75% of the standard water charge.

The discount is only given for calls within the ESI certificate's validity period and where the ESI registration is shown in the call notification.

ESI score = environmental ship index.

1.2 Quey fee

Quey fee are calculated on the basis of gross tonnes (GT). Exemptions and discount schemes are described in the business conditions for Harstad Havn.

About the use of EPI

Port of Harstad uses the environmental price index EPI (Environmental Port Index) to set prices for quay fees for cruise ships.

The cruise ship must have submitted its data within 72 hours after the end of the call. Cruise ships that do not meet this will receive an EPI score equal to 0 (see business conditions).

The following model is used to determine quay damages.

1.3 Waste fee/ship renovation

A waste fee is charged to all vessels calling at a public quay, regardless of whether waste is delivered from the vessel to the waste scheme. The fee must be calculated on the basis of the vessel's gross tonnage, or the amount of waste delivered. Harstad harbor has waste containers and source sorting for commercial vessels in environmental stations. For recreational vessels, there are rubbish bins at the guest quays in the centre. If larger quantities of waste (over $1 \, \text{m}^3$) are to be delivered, a separate request must be sent to the harbor guard and the vessel will be invoiced for the actual cost + $15 \, \%$ processing fee (max. NOK 15,000).

Clearing of the quay must be done by the consignee. In the event of failure to do so, cleaning will be invoiced for actual costs and elapsed time.

2.2 Remuneration for interim storage and use of the quay

Cargo for which freight consideration is paid can lie freely on our docks for up to 24 hours before loading and up to 24 hours after unloading. In addition to this, it is paid per day started.
